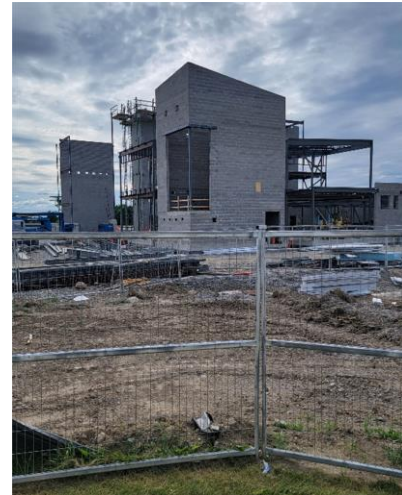
OVERVIEW

Largest construction project in the history of the United Counties of Leeds and Grenville at a cost of \$80 million dollars.

Total number of resident beds is 192 (includes 60 residents currently at Maple View Lodge).

First-class home away from home at an affordable price.

Target completion date: Spring 2025.
Residents move in: Summer 2025.
