### BACKGROUND

The Investment in Affordable Housing (IAH) for Ontario Program Guidelines require Service Managers to establish maximum income levels for IAH-funded rental housing units. Service Managers must also establish a method to verify income in order to ensure that households in need are targeted. Annual income verification is at the discretion of the Service Manager.

### PURPOSE

This Directive is for the purpose of notifying all affordable housing providers within the United Counties of Leeds and Grenville of household income limits applicable to households occupying affordable housing units, and to advise the method of verifying income of affordable housing tenants.

### ACTION TO BE TAKEN

Effective January 1, 2025 maximum household income limits for affordable housing in Leeds Grenville are as follows:

<b>Unit Size</b>	<b>Maximum Household Income</b>
1 bedroom	\$50,400
2 bedroom	\$59,400
3 bedroom	\$64,200
4 bedroom	\$75,000

Household income shall be verified annually by requesting a copy of the Notice of Assessment
