



## **Notice of Joint Public Meeting**

### **Realignment of Municipal Boundaries**

#### **Township of Elizabethtown-Kitley, City of Brockville and United Counties of Leeds and Grenville**

The Township of Elizabethtown-Kitley, City of Brockville and the United Counties of Leeds and Grenville (the affected municipalities) have drafted an agreement for the transfer of land (the annexed lands), located within the Township of Elizabethtown-Kitley and United Counties of Leeds and Grenville to the City of Brockville by way of a boundary adjustment proposal pursuant to sections 172 and 173 of the Municipal Act, 2001, Chapter 25.

A proposed boundary adjustment agreement is the subject of the public meeting for the realignment of the municipal boundaries that would annex property from the Township of Elizabethtown-Kitley and the United Counties of Leeds and Grenville into the City of Brockville. The Joint Public Meeting has been scheduled to present the municipal boundary adjustment proposal and to hear from interested persons with respect to the proposal.
